1. CALL to ORDER: 12:45 pm.

2. APPROVAL OF MINUTES: A motion to approve the minutes of the special BOD meeting on 2/11/2025 and of the regular BOD meeting on 2/17/2025. It was made by Ted Beilman, seconded by John Garton and approved by all board members.

3. TREASURER'S REPORT: Ted Beilman

- The club should remain liquid for at least 4 years, barring any unforeseen large expenses.
- The next top dressing will be done end April to level voids and spots. The cost of \$4,200 seems high and discussions took place. We do not have the proper equipment and volunteers to do it ourselves. The professional equipment used will ensure an even spread of sand, impossible to duplicate by hand.
- Sean highly encourages doing something to discourage aggressive weed growth on the green surrounds, 10'-12'.
 Ted will research costs of mulch and weed killer.

4. MEMBERSHIP REPORT: John Garton

- There are still 57 members.
- There is a pending membership for Hans Petersen (President, Sarasota County Croquet).
- For future memberships for paying students, consider the reduction in membership fee to more closely resemble to cost of the class.
- Prorated memberships approved at the 2/11 meeting, will be presented at the AGM.
- Confirming Off-Season is May to October.
- Sales are brisk of overstock surplus shirts that have been in storage.
- Contact day players to access their on-going interest in lawn bowling and encourage membership.

5. AGM: Annual General Meeting

- The nominating committee (John & Ilona) have not yet identified any candidates for the open positions: Vice President (2 yrs), Hospitality (2 yrs) and Tournaments (1 yr).

- Some members appear to be possibilities for later or special purposes.
- Strategic Plan: 2025 2026. Has not changed much, and will be updated.
- Ted to compile a treasury report with graphics for the meeting.

6. Grants and Fundraising

- Sally suggested that next season a silent/blind online auction be held to raise funds.

 John researched and observed there are several free apps we could use.
- The SLBC presentation appeared to be well received at the city meeting. Then Jerry Fogel said Parks Dept resources could not be justified for a small select group of parks users.
- At the suggestion of others attending the meeting, Sally contacted and met with Leon Thibeaut. Leon is on a parks advisory committee for Sarasota County. He suggests Sarasota County is a better fit for SLBC. More funds and better locations are available. The County is also a strong supporter of Sports Tourism. He suggests contacting Nicole Rissler, Sarasota County Director of Parks and Natural Resources. The County would be indirectly supporting Sarasota County Croquet by supporting SLBC.
- Sally reported on the Bowls USA Town Hall.

Pam Edwards, president, confirmed the mission is to grow the sport. Grants of \$15,000 (total) are available to clubs. A Youth Bowls committee was created. Free coaching advice will be available to clubs, probably online. VP Kane Tobin focuses on issues related to dealing with municipalities. Linda Roberts' forte is how to work with governments.

March through September will likely produce operating losses and slowly bring down our \$41K MM and Checking balance. Coaching Fees, President Draw Revenue including donations, and avoidance of discretionary expenses are extremely important for us now and until we begin collecting dues again starting in October.
